Dene K'éh Kusān Update

This spring and summer have been very productive, and we've made significant strides with the Kaska IPCA in Northern British Columbia. Over the past year, we've visited each Kaska community, engaging with members and receiving tremendous support and encouragement.

A highlight was the Grand Opening Celebration in Daylu this June, where we celebrated the opening of an important new building for our people. The event was not only a remembrance of our past but also a vision of our journey ahead. The screening of our film 'Dene K'éh Kusān' on the third day captured that vision and our path as a Nation, reinforcing our deep connection to our land - where our ancestors walked, our traditions began, and where we live to this today. It served as a powerful reminder of our collective responsibility to protect and sustain our lands and waters for future generations. Healthy lands mean healthy communities. "Dene K'éh Kusān represents our dreams and aspirations for the future. It embodies our collective vision for a future where Kaska land thrives, where our cultural heritage is preserved, and where our community stands strong and united. 


Informational Videos

What is an IPCA?




What Are Carbon Credits?

source revenue, all while protecting our intact ecosystems and restoring our forests.


